Policy on University of Wisconsin System Array Management: Program Planning, Delivery, Review, and Reporting



NEW PROGRAM APPROVAL PROCESS

Notice of Intent (NOI)

> Institution submits NOI

Provosts and OAA review and provide comments or concerns

DASA facilitates discussion, if needed

AVP of OAA approves or denies the request to plan

Approved to Request for Plan Institution develops a proposal for authorization by the BOR **Proposal incudes:**

An extended narrative including the rationale for and academic structure of the proposed program

A financial analysis

A letter of commitment from the university provost, including assurances that financial, capital, and human resources capacity exist at the university Authorization Institution submits authorization documents to OAA

> OAA staff review documents; staff from Office of Budget & **Planning review** budget and tuition structure

> AVP of OAA and VP of DASA review and recommend program to President

President recommends approval of new programs to BOR Education Committee and full BOR for approval

Monitoring All UW universities have policies and processes in place for monitoring programs and evaluating program array


Process

Sys 102 also requires annual monitoring of systemwide program productivity; OAA and OPAR prepare data to assist UWs in assessing program productivity

OAA prepares an annual program monitoring report that is shared with the UW President and the Regents




PROGRAM ELIMINATION PROCESSES

UWS Academic Program Changes July 1, 2023 to July 15, 2024





5-YR PROGRAMS TRENDS BY AREA JULY 2019-JUNE 2024





PROGRAM MODE OF DELIVERY




In-person includes programs reported as being offered only via face-to-face delivery. Distance Education includes programs reported as being offered at least 50% via distance education.
