ANNUAL PERFORMANCE EVALUATION

Pursuant to Wis. Stat. § 118.40(2x)(b)2.a-b., the Performance Framework will be used to assess school performance on an annual basis. The scores in each component of the Framework will be compiled and reviewed in collaboration with the leadership team of the charter school. If a school fails receives a cumulative score of "Far Below Standards" in any given year, the following action will be taken:

- If such failure has occurred for fewer than three consecutive years, the school will submit a remediation plan describing the corrective measures it will take to meet the indicators that received a score of "Far Below Standards" by July 1 of each year when required.
- If such failure has occurred for three consecutive years or more, the charter school shall be in default of the contract and subject to revocation of its charter; however lesser remedial action as may be determined by the OEO at its sole discretion.

Educational Programming

O.2. Board Governance and Reporting

O.3. Boad Compliance - The school materially complies with applicable laws, rules, regulations, and provisions of the charter Contract relating to governance by its Board, including but not limited to Board policies, Board bylaws, open meetings laws, code of ethics, conflicts of interest, Board composition and/or membership rules.

O.4. Reporting requirements - The school materially complies with reporting requirements to the Office of Educational Opportunity, Department of Public Instruction, and U.S. Department of Education.

Student Admission and Protections

O.5. Compliance with students with disabilities - Consistent with the school's status and responsibilities as a Local Education Agency (LEA), the school materially complies with applicable laws, rules, regulations, and provisions of the charter contract (including the Individuals with Disabilities Education Act, Section 504 of the Rehabilitation Act of 1973, and the Americans with Disabilities Act) relating to the treatment of students with identified disabilities and those suspected of having a disability.
